

# 2018 Xtreme Challenge

IKWF Wrestling Tournament – Sunday, December 2, 2018

**\*Limited to 600 Participants\***

**Please bring a bag/folding chair! No coolers allowed!**

**Tournament held in PE Center. 8 mats! Lots of room but limited bleacher seating.**

- Location:** Byron Park District, 420 N. Colfax, Byron, IL 61010 (12 miles south of Rockford)
- Divisions:** Tot (5 & Under); Bantam (6-7); Intermediate (8-9); Novice (10-11); Senior (12-14)  
Age will be as of September 1, 2018  
**3” Custom Xtreme Medals for All Wrestlers!!!**  
**Wrestlers cannot wrestle in more than one division.**
- Format:** Folkstyle: Tot, Bantam, Intermediate - 4 man round robin. Periods (1-1-1 min.)  
Novice and Senior – 4 man round robin. Periods (1 ½ -1 ½-1 ½ min.)  
Seniors wrestle on full mats!
- Times:** **Weigh-ins** - Sunday, December 2, 2018 6:30-8:00 AM in wrestling room located near south side of gym.  
Wrestling will begin immediately following bracketing.
- Entry Fee:** **\$100 Deposit to reserve your team’s spot. Deposit and estimate of participants from your club is due by November 16<sup>th</sup>.**  
\$20 per wrestler (non-refundable). All wrestlers must be pre-registered and fill out individual entry form.  
**No Walk-ins Taken at the Door! Make checks payable to Byron Wrestling Association. All Outstanding Balances and Individual Entry Forms are Due November 27, 2018. We will not accept individual entries. All entries from any given team should be mailed together by the team**

- Due Dates:** Team deposit and estimate of your club wrestlers is due by November 16, 2018  
Entry forms and payments are due by November 27, 2018. **All teams must be pre-paid and have entry forms to the tournament director by November 27, 2018.**
- Wrestler Info:** Each wrestler/team should be able to present USA Wrestling cards and IKWF verification.  
**ABSOLUTELY NO ONE WILL WRESTLE WITHOUT A CARD OR OFFICIAL WRITTEN OR WEBSITE VERIFICATION FROM THE IKWF. . No refunds for “no-shows” or wrestlers without USA cards or wrestlers with skin conditions but without a “IHSA” doctor’s note.**
- Coach Info:** There will be a coach’s check-in for all coaches. All coaches wanting to be matside will need to check in and get a wristband to be allowed in the roped in area around the mats. Coaches must have a current USA Wrestling Leader card, must be at a minimum Copper certified to be mat side, provide valid identification at check-in, and be listed on a IKWF Team Roster.
- Rules:** We will check body, hair, skin and fingernails. You must have signed and dated IHSA form in hand for any skin condition. Forms can be found on IHSA website. Head gear, singlets, and taped/covered shoelaces are required. You can be turned away for any infraction. **No refunds.**
- Concessions:** Available in the Mary Morgan cafeteria all day.

**Waiver & Release from Liability**

The undersigned wrestler and the parents or guardians of the wrestler hereby represent to the Xtreme Wrestling Club as a sponsor of the Xtreme Challenge, that the wrestler's health is and will be sufficient to allow the wrestler to safely participate in the tournament. The undersigned understands and accepts that no health examination will be conducted by the Xtreme Wrestling Club to determine the wrestler's fitness to participate in the tournament and that health and accident insurance coverage of the wrestler, if any, is the sole responsibility of the undersigned. The undersigned understands and accepts that the wrestler participates in the tournament at the wrestler's own risk. The undersigned understands and agrees not to make any claims or bring any lawsuit for personal injury, death, property damage, or loss which arise out of the wrestler's participation in the tournament against the Xtreme Wrestling Club, Byron Wrestling Association, its Agents, Byron High School, or C.U.S.D. #226. The terms "Xtreme Wrestling Club" "Byron Wrestling Association," "Byron High School," and "C.U.S.D. #226" include the governing board of these entities and their officers, employees, and agents.

The undersigned, on behalf of myself, my heirs and next of kin, personal representatives, agents, insurers, successors and assigns (all hereafter "Releasers") hereby FOREVER RELEASE, DISCHARGE AND COVENANT NOT TO SUE THE UNITED STATES WRESTLING ASSOCIATION, INC., its insurers, its affiliated clubs, administrators, agents, directors, officers, state organizations, members, committees, volunteers, all employees of USA Wrestling, and any and all participants, officials, referees, coaches, host clubs, sponsoring agencies, sponsors, advertisers, local organizing committees (and if applicable) owners, lessors and operators of premises used to conduct any USA Wrestling sanctioned event, meet, practice or activity (all hereinafter "Releases") from any and all liabilities, claims, demands, causes of action or losses of any kind or nature, past, present or future, direct or consequential that I may hereafter have for PERSONAL INJURY, PERMANENT, TEMPORARY, TOTAL OR PARTIAL DISABILITY, DISFIGUREMENT, PARALYSIS AND ANY OTHER LOSSES OR DAMAGES TO PERSON OR PROPERTY OR DEATH, arising out of my participation in, attendance at or traveling to and from any USA Wrestling sanctioned event or activity including, but not limited to, LOSSES CAUSED BY THE PASSIVE OR ACTIVE NEGLIGENCE OF THE RELEASEES, or hidden, latent or obvious defects in the facilities or equipment used.

Releasor understands and acknowledges that USA Wrestling sanctioned activities and the sport of wrestling in general have inherent dangers that no amount of care, caution, training, instruction, supervision or expertise can eliminate. RELEASOR EXPRESSLY AND VOLUNTARILY ASSUMES ALL RISK OF PERSONAL INJURY, PERMANENT, TEMPORARY, TOTAL OR PARTIAL DISABILITY, DISFIGUREMENT, PARALYSIS AND OTHER LOSSES OR DAMAGES TO PERSON OR PROPERTY OR DEATH, sustained while participating in, attending, preparing for or traveling to and from any USA Wrestling sanctioned event, meet, practice or activity, including the risk of PASSIVE OR ACTIVE NEGLIGENCE OR THE RELEASEES, or hidden, latent or obvious defects in the facilities or equipment used.
3. Releasor acknowledges and fully understands that each participant in any USA Wrestling sanctioned event, meet, practice or activity, including Releasor, will be engaging in activities that involve risk of serious injury, including permanent, temporary, total or partial disability, disfigurement, paralysis and any other losses to person or property, including death, and that severe social and economic losses may result not only from Releasor's own actions, in actions or negligence, but also from the actions, in actions or negligence of others notwithstanding the rules of play or the condition of the premises or of any equipment used. Further Releasor acknowledges and fully understands that there may be other associated risks with such activities which are not known or not reasonably foreseeable at the time. I ACKNOWLEDGE THAT I HAVE HAD SUFFICIENT OPPORTUNITY TO REVIEW THE PROVISIONS OF THIS DOCUMENT AND UNDERSTAND ITS PURPOSE, MEANING AND INTENT.
